

## Promise the Children

*“If you don’t like the way the world is, you change it. You have an obligation to change it. You just do it one step at a time.”* Marion Wright Edelman

As a result of the Personal Responsibility and Work Opportunity Reconciliation Act of 1996 (Welfare Reform Act), the UUA, with the guidance of the UU Service Committee, launched the Promise the Children Initiative to monitor the effect this legislation would have on the lives of children.

Locally, long time social justice advocates and members, Bill Brach (also on the UUSC Board) and Frank Rennie, organized our Promise the Children Committee, with contributions made by Jackie Lahey, Diana Autin, Diane Connell, among others. Similar to today’s UU Legislative Ministry of NJ initiative, the group met with UU congregations across the state to work on policy, advocacy and lobbying for children’s welfare.

One of the group’s outcomes was the establishment of the After School Tutoring program, now in its 11th year. Its purpose was, and continues to be, the leveling of the academic and technological playing field for all children.

In January of 2007, Joe Thomasberger conducted a worship service on the current status of children, during which he invited members and friends to join him in reinvigorating the temporarily lapsed committee. Nine persons gathered the following month to renew the Promise the Children Committee.

Striving to be a channel for the Congregation to provide direct assistance to children and families in special need;

Engaging in research, study and action on behalf of the Congregation in consultation with religious and other concerned organizations to address public policy issues that affect children and their families.
