#### **Administrator's Report**

A marriage equality group wishes to begin renting at \$400 per month for a period of six months and there is a possible rental by an after-school program, at \$75 per month, beginning in January.

A nursery school/day care program proposes to rent our facilities at \$2500 per month in September 2013. They are preparing a presentation to the Board.

# **Treasurer's Report - Judy Strachan**

Financials overall are healthy. Pledge income year to date is over budget while short and long-term rentals and fundraising continue to be under budget. The auction has come in on budget.

## President's Report

Five committees sent representatives to the recent visionary workshop, which was well received.

The name change from Nominating to Nominating and Leadership Development Committee will broaden the scope of the group and have it serve as a conduit, along with Adult RE and Harvest the Power, for development of leaders in the entire congregation. *Participants will serve a three-year term, subject to the pleasure of the Board.* We will hold a congregational meeting on January 27<sup>th</sup> to put the italicized bylaw revisions to a vote.

The auction netted \$29,700 after \$1,000 was deducted for expenses.

The music committee has completed its evaluation of Marcus Hauck and recommends extending his employment.

Laura Wilson has stepped out of the book sale, resulting in the decision not to hold the sale in 2013.
